GENERAL POLICIES OF BETHEL'S ALL DAY SUMMER PROGRAM

1. Children who are enrolled in our current or upcoming after-school program and members of Bethel United Methodist Church (up to 5th grade) are eligible for enrollment.
2. Enrollment will be open February 15th to our already enrolled preschoolers and members of the church. Enrollment will be open to the public March 1st. Available openings will be filled as we take applications.
3. Tuition for our all-day summer program is \$460 a month for the months June through August. Tuition is due at the beginning of the month and no later than the 10th. If tuition is not paid by the 10th a late fee of \$10 will be added and a \$20 late fee will be added after the 20th of the month. If tuition is not paid by the 21st of the month, your child will not be able to return until arrangements have been made to pay the past due tuition. A full months tuition is due regardless of the days attended during the month. In case of withdraw, tuition is still due until the date that is written on the 30-day notice, that needs to be given to the director.
4. Students will need to bring their own lunch that does not require to be microwaved, we can not heat anything up. Children that still nap need to bring a nap mat or sleeping bag, it will be sent home every weekend to be washed and returned on Monday. All students will have quiet time. Morning and afternoon snack is provided.
5. Every Friday is water day, weather permitting. Children must be sent in their swimming suits with sunblock already applied. Please bring an extra change of clothes, and a towel.
